<p>General Education Preschool 8:35-11:35 OR 12:20-3:20 Tuition see reversed side* Monday, Tuesday, Thursday, Friday*</p> <p>\$115 Non-refundable Registration Fee ** \$60.00 for siblings or returning students</p>	<p>These collaborative classrooms are between 18-20 students. Primary instruction is provided using a balance of teacher directed and student directed experiences. The curriculum is based on the California Preschool Learning Foundations. Adult to child ratio does not exceed 1:8.</p> <p>*No charge for income qualifying families based on the California State Preschool Program regulations. Students whose families qualify will also attend on Wednesdays. **Registration fee is waived for income qualifying families.</p>
<p>Specialized Instruction 8:35-11:35 OR 12:20-3:20 Monday, Tuesday, Thursday, Friday</p>	<p>These classrooms are designed for children who qualify for special education services and require a self-contained setting in order to address their unique areas of need. Typical class size does not exceed 12 students. Children must have an active Individualized Education Program. Adult to child ratio varies depending on the class.</p>
<p>Enrichment Classes See separate page for classes, fees, dates, and times.</p>	<p>A variety of specialized enrichment classes designed to support a successful transition to kindergarten. Classes include a drop-in parent participation program for children ages birth through five (Learning Link), social skills, language and learning, and school readiness classes.</p>

Childcare is available with an RSVP.</p>	<p>Parent education classes are offered on a monthly basis on a variety of topics related to young children. Classes are offered three times per day. See Parent Education handout for a description of classes.</p>

2016-2017 School Year

1. There is a non-refundable registration fee of **\$115.00** due upon submission of a completed enrollment packet. **\$60.00** fee for siblings or returning ECLC students.
2. Tuition payments are based on a **daily rate of \$36.00** times the number of school days in the month.
3. **No refunds or credits given if a child is absent, ill or on vacation.**
4. If the child withdraws from the program **prior to the next scheduled payment, no refunds are given.**
5. There will be an additional **\$25.00 late charge if the payment is received after the due date.** All services will be terminated immediately if payment is not received **within seven days of the due date.**
6. The preferred method of payment is on-line via My School Bucks, check or money order. Please make it payable to Irvine Unified School District and write your child's name and room number on the check. If a check has been returned for insufficient funds or a closed account, checks will no longer be accepted for payment and a \$25.00 fee assessed. Thereafter, cash, money orders or certified checks will be required.
